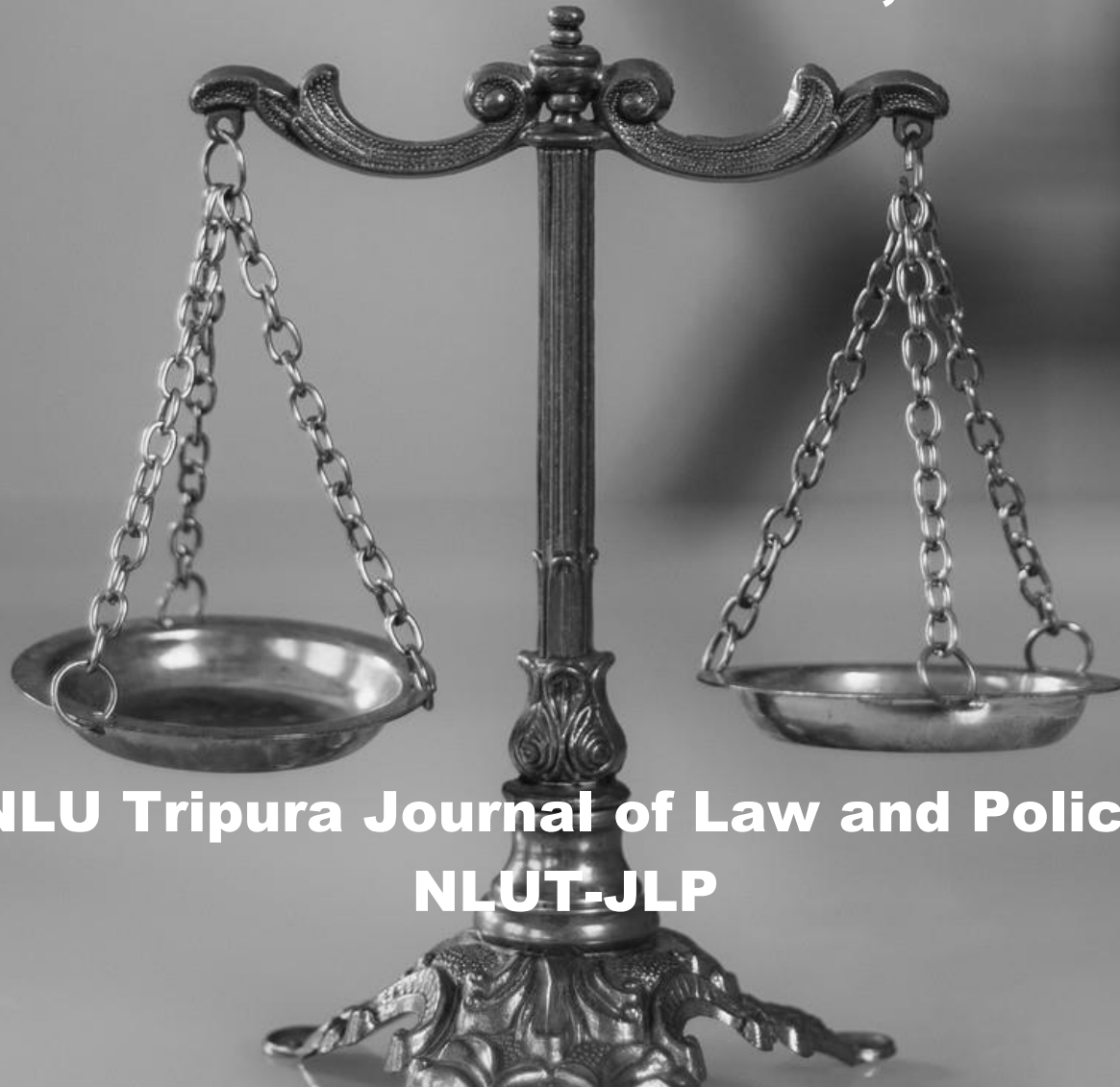

ABOUT THE JOURNAL

The legal landscape is dynamic, and the need for insightful analysis and discussions on emerging legal and policy issues is paramount. The “NLU Tripura Journal of Law and Policy” is flagship journal of NLU Tripura which aims to serve as a platform for legal scholars, practitioners, and policymakers to contribute to the discourse surrounding contemporary legal and policy matters.

The primary objective of the journal is to encourage research and scholarship in the fields of law and policy. It seeks to provide a space for the exchange of ideas, opinions, and innovative solutions to address the challenges faced by the legal and policy frameworks at local, national, and international levels.

- **Research Articles:** Original research articles that contribute new insights to legal and policy scholarship. Word limit: 8000-10000 words.
- **Case Comments:** Analysis of recent legal judgments and their implications. Word limit: 3000 words.
- **Legislative Reviews:** Examination of proposed or existing legislation and its impact on society. Word limit: 3000 words.
- **Book Reviews:** Reviews of recent publications in law and policy. Word limit: 2000-3000 words.
- **Interviews:** Conversations with legal and policy experts, practitioners, and scholars. Word limit: 3000 words.

Note: All the word limits mentioned above are exclusive of footnotes. Kindly note that the word limits will be strictly enforced.

Submission Guidelines

The NLU Tripura Journal of Law and Policy accepts submissions on a rolling basis from contributors. All submissions must be accompanied with a covering letter indicating the name of the author, title of the submission and the email address of the author. The submissions will be reviewed and edited by the Editorial Board under the supervision of the Editor- in-Chief. Submissions can be in the form of long articles, short notes, case comment/Legislative Comments and book reviews.

- Manuscripts should be original and not under consideration for publication elsewhere.
- Submissions with plagiarized content and copyright issues will be rejected outrightly.
- Submissions should adhere to the prescribed format and citation style.
- Authors are encouraged to submit articles that are relevant to contemporary legal and policy issues.
- Submissions will undergo a peer-review process to ensure the quality and relevance of the content.
- All the submissions must consist of an Abstract of not more than 300 words, highlighting the main contribution and a declaration of originality is also to be sent. The abstract will not be included in the word limit. The submission must be sent along with upto 6 Keywords mentioned below the Abstract in the manuscript.

Formatting and Citation Guidelines

1. An appropriate Title must be mentioned in the cover page of the submission. The Title should be Font Type and Size, Times New Roman and 16 respectively. It should be centre aligned.
2. The submission should not contain any biographical information of the author throughout the manuscript.
3. The body of the text must be font type - Times New Roman, Font Size 12. The alignment should be justified.

4. The footnotes must be font type - Time New Roman, Font Size 10. The alignment should be justified.
5. The Line Spacing of the main text and footnotes must be 1.5, 1 respectively.
6. Use of headings and Subheadings is encouraged throughout the text.
 - Headings: Centre Aligned, Bold, and Font Size - 14, Font Type - Times New Roman.
 - Subheadings: Justified Alignment, Bold, Italicized, Font Size - 12 and Font Type - Times New Roman.
7. Citations must be uniform and in the OSCOLA Format (4th Edition).

Publication Policy

1. By sending the submissions to NLU Tripura Journal of Law and Policy, the author(s) agree to assign exclusive copyright in the work to NLUT-JLP. It shall be entitled to, without limitation, publish and reproduce the submission (or part(s) thereof) in any manner it sees fit (with due acknowledgement to the author) subject to the doctrine of fair use as enumerated under the Copyright Act.
2. The editors reserve the right to edit the submissions (or part(s) thereof) for publication without permission from or further notice to the author.
3. After initial screening, short-listed submissions will go through a double-blind peer review process and the final selection will be based on that procedure.
4. All authors shall receive an acknowledgement of receipt of their work within 4 weeks of submission. If any submission does not pass any level review or is rejected for any reason such as originality, plagiarism etc., then a mail shall be sent to the author in due course of such rejection.

Frequency

The “NLU Tripura Journal of Law and Policy” will be published annually to ensure a timely dissemination of cutting-edge legal research.
