1. Introduction

The University has prepared the Annual Report regarding the University's activities for the Academic Year 2023-2024. This report is intended to be presented to the Governing Council of the University for its review and approval as mandated by Section 12(6) of the National Law University, Tripura Act 2022.

2. About the City of Agartala

The Capital city of Agartala (new) was founded in 1838 AD by Maharaja Krishna Kishore Manikya (1830-49 AD). The Agartala Municipality was instituted in 1871 AD during the reign of Maharaja Chandra Manikya (1862-96 AD). The Municipal Administration in Agartala was established in 1874 A.D. and the city became a planned city by the then Maharaja Bir Bikram Manikya Bahadur in 1940s. This erstwhile Princely State Capital of Tripura merged with India on 15th October 1949.

Agartala, Capital of Tripura, is situated on the banks of river Haora. It was also the capital of the former princely state of Tripura. It shot into prominence when Maharaja Krishna Kishore Manikya shifted his capital to the city. Agartala offers some outstandingly beautiful palaces, gardens, hills, temples and lakes. Perfection is the word for the architectural monuments of the city.

The red government buildings are in contrast against the remarkably usually white old British buildings that are still in existence and in use. Some of the monuments have been selected as UNESCO World Heritage Sites and RAMSAR sites. Agartala has a good sporting tradition too, with many sports and games being played. Especially favourite is football (soccer) with its own city football league known as Rakhal Shield. Agartala is famous for its seasonal fruits. The Queen and Kew varieties of pineapple are very popular. Tripura Orange is well known for its high juice content and special sweetness.

Oranges grown in Tripura have secured highest honour several times in the all India "Citrus Show." Do not forget to visit the pineapple gardens, litchi orchards, cashew orchards and orange gardens. It is the 3rd smallest amongst the Indian states and is located in an isolated hilly region of the country, with various indigenous people or tribes accounting for a significant portion of the population. Agartala is home to 19 indigenous tribal groups and Bengali speaking non-tribals. In the beautiful hills of Northeast India lies the city of Agartala. Being known for its breath-taking scenic view, this state is also popular for its tribe

culture and food. On March 31, 2024 the two most distinctive products of Tripura – the delectable Matabari Pera and the vibrant Pachra textiles have been awarded the coveted Geographical Indication (GI) tag.

3. Logo of the University

Justice Aparesh Kumar Singh was born on July 07, 1965. His Lordship passed B.A. Honours and obtained L.L.B Degree from University of Delhi. In the Year 1990, His Lordship got enrolled as Advocate and practiced at Patna High Court from 1990 to 2000 and in the High Court of Jharkhand since 2001 till His Lordship's elevation as Judge of High Court of Jharkhand. His Lordship was appointed as Additional Judge of the High Court of Jharkhand on January 24, 2012 and confirmed as Permanent Judge on January 16, 2014. His Lordship also held the post of Executive Chairman of Jharkhand State Legal Services Authority. He took oath as the Hon'ble Chief Justice of the High Court of Tripura on April 17, 2023.

10. University Administration

10.1 Vice-Chancellor



Prof. (Dr.) Yogesh Pratap Singh Vice-Chancellor, NLU Tripura

Prof. (Dr.) Yogesh Pratap Singh is an alumnus of National Law School of India University (NLSIU), Bangalore, and completed his LL.B. from the University of Allahabad. His doctoral thesis entitled "Contribution of Dissenting Opinions of Indian Supreme Court Judges to the Indian Legal System: A Critical Evaluation," is recognized as a significant contribution to the understanding of the voting patterns of judges in the Supreme Court of India. This work was later published as book entitled "Judicial Dissent and Indian Supreme Court: Enriching Constitutional Discourse" by Thomson Reuters. Honourable Justice Dr. D.Y. Chandrachud, Judge and Chief Justice of India authored a scholarly foreword for this book. Dr. Singh served as Deputy Registrar of Research in the Supreme Court of India (on deputation) from May 2016 to October 2018.

Dr. Yogesh participated in the 39th Annual Session on International Human Rights Law organized by International Institute of Human Rights (IIHR) Strasbourg, France. Dr. Yogesh was also part of Ciedhu program in France conducted for University Teachers. Prior to joining the National Law University Odisha in 2009, when it was established, he was part of the founding team of KIIT Law School, KIIT University, Bhubaneswar. Dr. Singh has also worked as a Legal Researcher at the Rural Litigation and Entitlement Kendra (RLEK) in Dehradun.

Prof. Singh has presented numerous papers on constitutional, social, and legal issues at various national and international seminars. He constantly writes in the field of law in reputed law chronicles, national and international law journals. Dr. Singh also writes for the general public, contributing recurrently to The New Indian Express, The Statesman, The Tribune, Deccan Herald, The Wire.

10.2 Registrar



Prof. (Dr.) Nachiketa Mittal Registrar (I/C), NLU Tripura

Dr. Nachiketa Mittal formerly served as the Professor of ADR at the National Law Institute University, Bhopal, and as Professor of Law and Director of the Faculty of Law at Jagran Lakecity University, Bhopal. He has also worked as the Dean (I/C) of the United World School of Law, Karnavati University, Gandhinagar, and as an Assistant Professor of Law at the National Law University Odisha, Cuttack. Dr. Mittal started his career as an empirical researcher, law trainer, and projects coordinator with New Delhi and Dehradun-based civil society organizations. Dr. Mittal has conducted empirical studies in more than 150 villages in India as part of research and empowerment programs for women, children, disadvantaged groups, and the indigenous population. During his academic career, Dr. Mittal was invited by the then Chief Justice of India to work in the Supreme Court of India as Assistant Registrar (Research) in 2016. Due to his passion for legal education, Dr. Mittal founded three online law teaching platforms during the national lockdown and outbreak of Covid-19. These are Virtual Law School (VLS) under the aegis of KETAS Education Foundation (Sec. 8 Company and 80G approved by the Income Tax Authorities); Judicial Preparation and Advisory Center (JPAC) and CareerRun Consulting. Dr. Mittal is also leading an empirical research project to examine the growing implications of ChatGPT and similar Artificial Intelligence in legal research and law schools. Dr. Mittal has presented papers and lectured in various law schools in the United States and has published in a wide range of international and national law journals. Dr. Mittal also received a Scholarship from the Charitable Trust Committee of the International Bar Association, London, in 2008.





13.3 Admission Report AY 2023-24 & 2024-25

NLU Tripura started its academic activities from AY 2023-24. University conducted its own admission test to select students for UG and PG programmes for the AY 2023-24. The entrance exam was conducted on five centres namely Agartala, New Delhi, Bhopal, Kolkata and Guwahati. First batch of BALLB (Hons.) consisted 44 students while in LL.M. University admitted 28 students.

13.4 Doctor of Philosophy (Ph.D.)

19. Research Projects

19.1 COTPA Survey





An Endline Compliance survey under the Cigarettes and Other Tobacco Products Prohibition Act (COTPA) 2003 was conducted in which the districts of West Tripura, North Tripura, South Tripura, Gomati, Unakoti, Sepahijala, Dhalai, and Khowai were thoroughly investigated. Surveyors visited schools, government offices, shops and other public places in order to find out the compliance of COTPA regulations. Interestingly, certain government offices, educational institutions, and other places did not have NO SMOKING signage indicating prohibition of smoking. In cases where such signs were present, they often failed to provide clear instructions regarding the individuals responsible for paying penalties and the specific grounds for which penalties would be imposed. Smoking and tobacco usage were detected outside the workplace. Citizens will not comply with rules and regulations until the government applies punitive penalties. NGOs must be more involved to promote proper legal information. *Prof. Yogesh Pratap Singh was the principal investigator*.

19.2 Comprehensive Review of all Acts/Rules administered by the State of Tripura to simplify, decriminalize and remove redundant laws as well as eliminate the risk of imprisonment for minor violations

The legal framework of any state plays a critical role in its governance, economic development and social justice. However, over time, legal systems can become cluttered with outdated, redundant or overly punitive laws. This research undertaken by NLU Tripura and funded by Dept. of Good Governance, Govt of Tripura aims to undertake a comprehensive review of all acts and rules administered by the State of Tripura with the objectives of simplifying the legal code, decriminalizing minor offences and removing laws that are no longer relevant or necessary. *The Principal Investigator of the project is Prof.*

(Dr.) Yogesh Pratap Singh and Research Associate and Research Assistant of the projects are Prof. (Dr.) Nachiketa Mittal and Dr. Ripon Bhattacharjee respectively.

19.3 Empowering Indigenous Communities: An Analysis of Social Welfare Schemes in Tripura for Scheduled Tribes





The Research Project titled, "Empowering Indigenous Communities: An Analysis of Social Welfare Schemes in Tripura for Scheduled Tribes" has been accepted by the West Bengal National University of Juridical Sciences (WBNUJS). The research project aims to understand the demographic profile and various tribal communities in the state of Tripura. It analyses the welfare schemes of Scheduled Tribes (STs) by Government of Tripura; further, it will also study the implementation framework of the welfare schemes for the development of the Schedule Tribe population in Tripura. Furthermore, the project will suggest the reformatory guidelines and policy framework to improve the condition of ST and the laws relating to such welfare schemes. The Principal Investigator of this project is Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, National Law University, Tripura and Co-Principal Investigators are Dr. Jayanta Ghosh, Assistant Professor of Law, The W.B. National University of Juridical Sciences, Kolkata and Dr. Debasree Debnath, Assistant Professor of Law, National Law University, Tripura.



20.11 Speech Competition




20.12 Ambedkar Day Lecture"




20.13 Five-Days LL.M. Dissertation Writing Workshop

20.17 CV/Resume Drafting Workshop



27. Memorandums of Understanding






