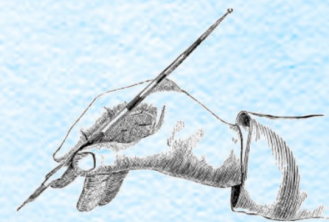

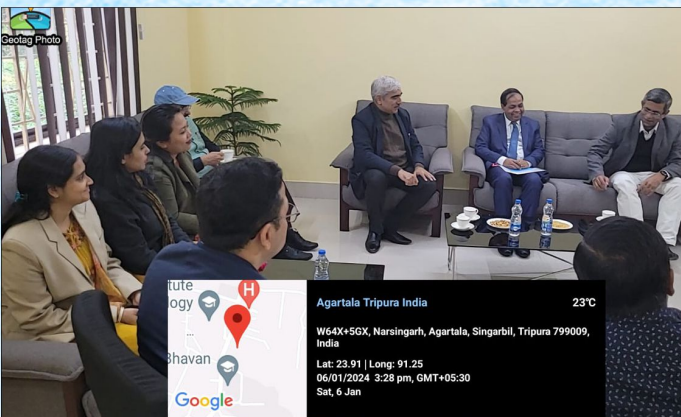
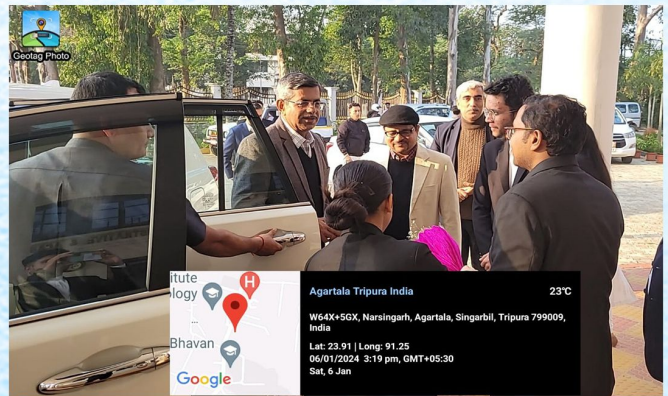

# Chancellor's Visit



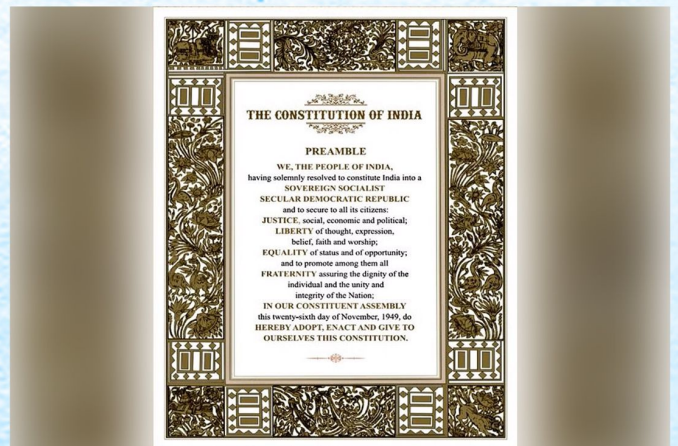

# Republic Day



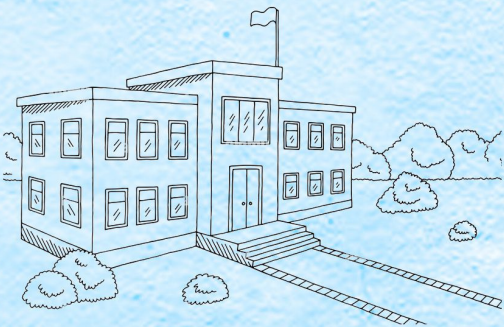

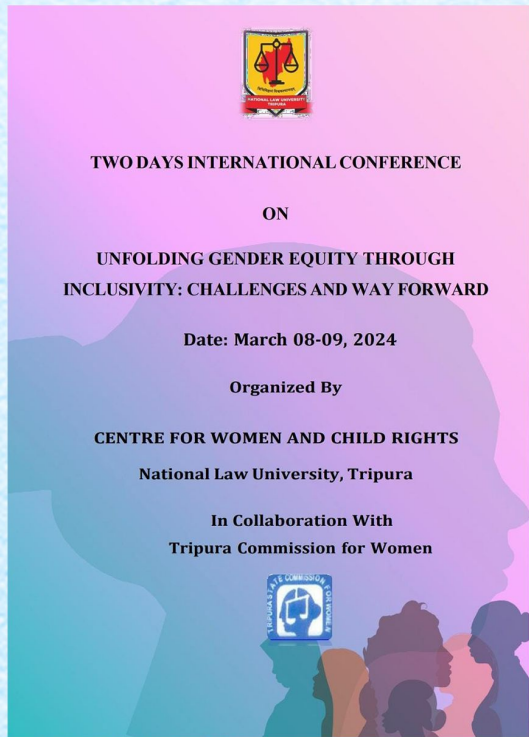
# School Connect Programme

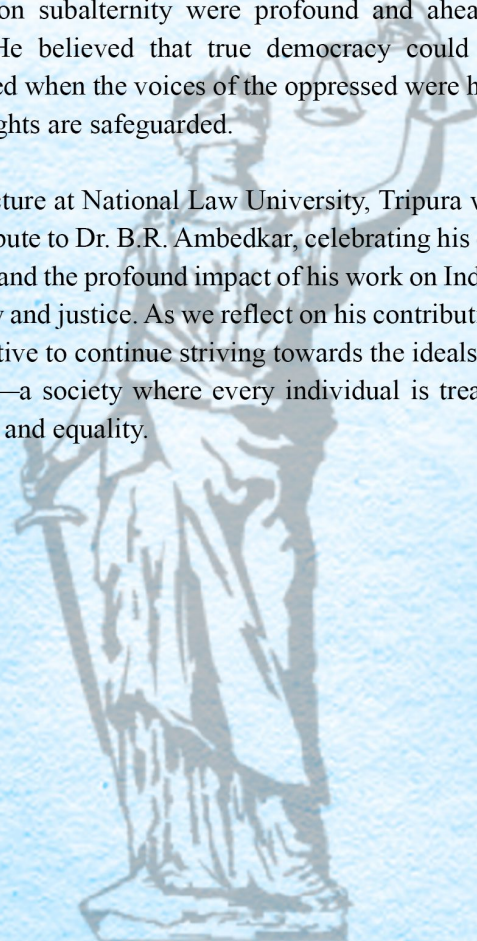

The students actively participated in the session, asked general and specific questions about their tentative topics, and utilised this opportunity to enhance their dissertation writing skills.

Overall, the inaugural Ph.D. Orientation Program was a resounding success, laying a strong foundation for the academic journey of the new scholars at National Law University, Tripura.

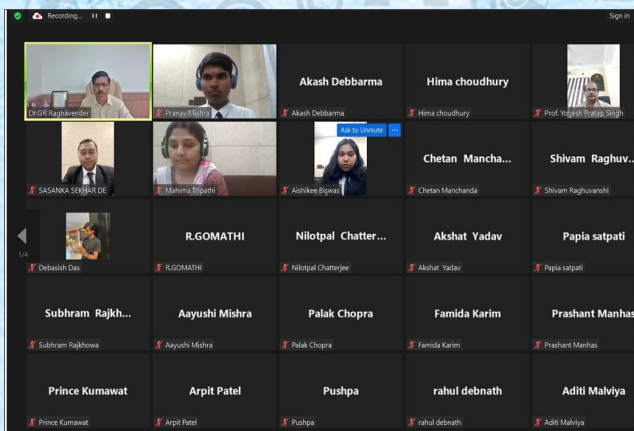




# Intellectual Property Right (IPR) Day

He discussed various challenges to copyright protection posed by emerging technologies and proposed solutions to foster innovation while safeguarding creators’ rights. His note delved into the challenges posed by emerging technologies mainly to copyright protection and suggested a path forward to ensure innovation thrives while safeguarding creators' rights with several legal precedents in India and abroad.



# Expert Lecture Series



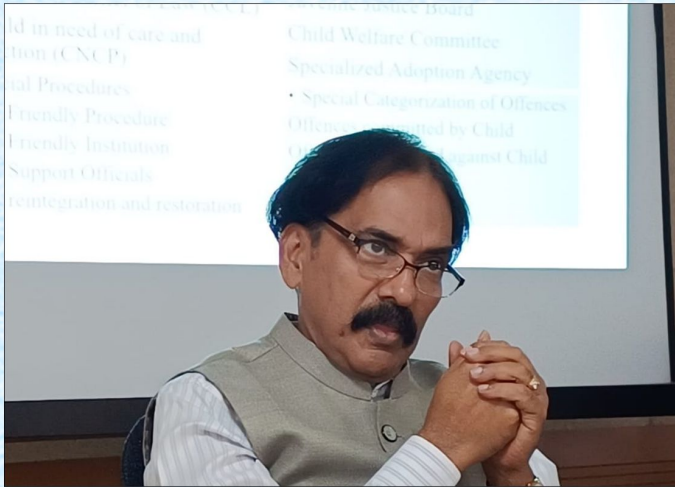
## 1. Mr. Hrishikesh Chakraborti, Director, Tripura Judicial Academy

Mr. Hrishikesh Chakraborty, Director of Tripura Judicial Academy, delivered an in-depth lecture on “Internet and Cybercrime” on February 22, 2024 to the LL.M. students at National Law University, Tripura. This enlightening session delved into the intricacies of cyber law, the nuances of digital evidence, and the emerging challenges posed by cyber threats in the digital age. Emphasizing real-world applications and case studies, the lecture provided a comprehensive understanding of legal frameworks, enforcement mechanisms, and preventive measures in combating cybercrime, thereby enhancing the students’ knowledge and preparedness to address complex issues in the evolving landscape of cyber law.



The discussion then traced the origin of Western jurisprudence to the Justinian Empire, examined the concept of “mule” in various contexts, and highlighted the historical evolution of Constantinople to Istanbul. The lecture was further enriched by insights into current affairs, including INTERPOL’s headquarters and Julian Assange’s controversial role in U.S. elections through WikiLeaks. To complement the academic discourse, Mr. Hrishikesh recommended a curated list of films, including “For a Few Dollars More,” “The Matrix Trilogy,” “Bounty Hunter,” and “The Mule,” encouraging students to broaden their understanding through cinematic narratives. This multifaceted approach to legal education exemplifies National Law University’s commitment to fostering well-rounded legal professionals equipped to navigate the complexities of the modern world.

## 2. Hon'ble Mr. Justice S.G. Chattopadhyay, Judge, High Court of Tripura



Honourable Mr. Justice S.G. Chattopadhyaya delivered a lecture on the theoretical and pragmatic perspectives of the working of the Juvenile Justice Act 2015. He gave special emphasis on Child in need of care and protection and child in conflict with law. Mr. Chattopadhyaya shared his experience during his professional life wherein he found critical issues that often resulted due to lack of sensitivity about the JJA and highlighted the need for adequate dissemination of the statute among the masses.



Mr. Chattopadhyaya further highlighted several grey areas that call for serious academic research to ensure adequate realization of the objectives of the act. The session started with a warm welcome from the Vice Chancellor, National Law University Tripura equipped with the smart class concept blended with interactive discourse followed by a question and answer session and ended with a vote of thanks from Prof (Dr.) Nachiketa Mittal, Registrar, National Law University, Tripura.



### 3. Ms. Jaya Goyal, Neo Juris, Advocate and Solicitors, Faculty of Law, University of Delhi



“Expert Lecture Series” organised by National Law University Tripura on January 26, 2024 was graced by one of the very eminent Advocates and Solicitors, Ms. Jaya Goyal, Managing Partner at Neo Juris LLP and Director of training at AIIMAS (Association For India International Mediation and Arbitration Services). The speaker delivered a lecture on the importance of Arbitration, Conciliation & Mediation. These elements offer efficient, confidential, and cost-effective alternatives to litigation and thereby help in reducing court backlogs, promoting amicable settlements, and maintaining relationships. For lawyers, they provide opportunities to specialize and develop essential negotiation and mediation skills, enhancing their professional versatility and career prospects. The increasing complexity of global commerce and international disputes further enhances the demand for skilled arbitrators and conciliators. Additionally, it allows lawyers to foster negotiation, mediation, and conflict resolution skills, essential for modern legal practice. Engaging in ADR can lead to greater professional satisfaction by contributing to fair and amicable solutions, making it a rewarding path for young lawyers.



## 4. A. Ramesh Reddy, IPS Officer and the Deputy Inspector General of Police, Tripura



The Literary and Debating Society, National Law University, Tripura conducted an interactive talk-session on “Synergy between Law Enforcement Officers and Law Officers” on June 21, 2024 by A. Ramesh Reddy, the Deputy Inspector General of Police, Tripura.

The talk was very captivating as many budding legal scholars participated and came up with various crippling issues including – corruption in police service, custodial violence and on-ground realities of police investigations. He shared insightful connections between Police and Law Officers and answered all queries of the participants with verbal humour. The 54<sup>th</sup> ranked IPS cadre explained his uneven journey and earnest service as a Police personnel. The storming session aimed at fostering greater understanding and collaboration between legal professionals and law enforcement personnel.



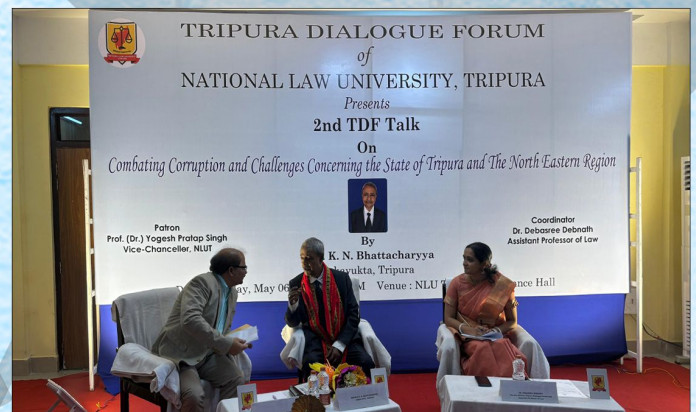

# 2<sup>nd</sup> TDF Talk

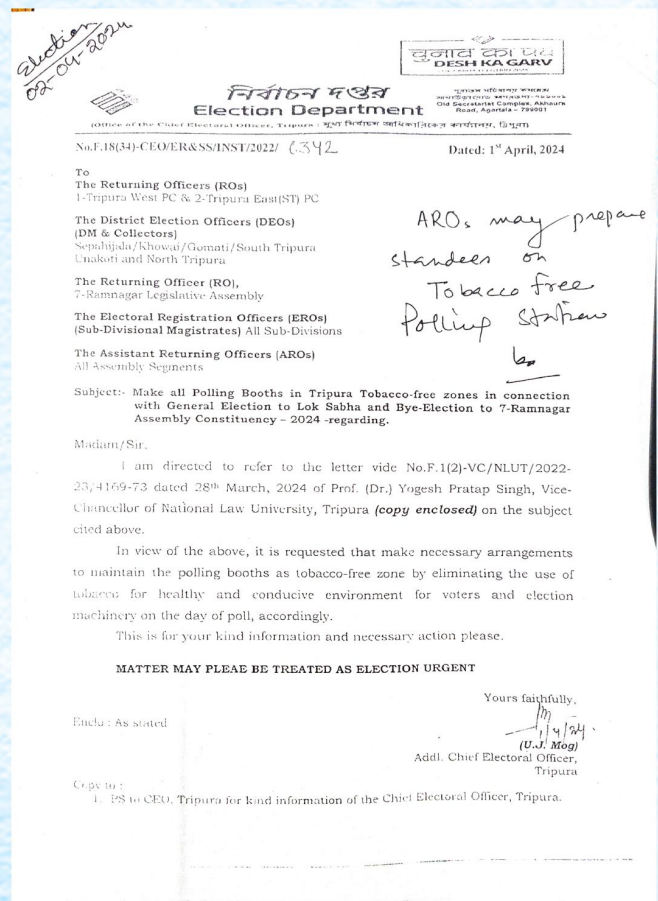


The Tripura Dialogue Forum (TDF) organized its second TDF Talk on “Combating Corruption and Challenges Concerning the State of Tripura and the North Eastern Region” on May 06, 2024. The distinguished speaker for the event was the Lokayukta of Tripura, Sri Kalyan Narayan Bhattacharyya. In his insightful address, Mr. Bhattacharyya shed light on the role, jurisdiction, and procedural aspects followed by both the Lokayukta and Lokpal when dealing with corruption cases. He also candidly discussed the challenges and gaps within the existing system. During the interactive session, Mr. Bhattacharyya engaged with students and emphasized that corruption has far-reaching implications for society and advocated for a multifaceted approach to combat it. In addition to legal mechanisms, he stressed the importance of value education as a means to tackle corruption effectively.



# Release of Comprehensive Report on COTPA Survey

The North-Eastern states of India face a significant public health challenge marked by the high prevalence of tobacco use. Despite various regulatory measures in place, the widespread use of tobacco products poses a considerable threat to the well-being of the population in these regions. There is substantial variation in the prevalence of tobacco use by state, ranging from 9.7% in the southern state of Goa to 64.5% in the north-eastern state of Tripura. Considering this concern of the state, a comprehensive End Line Compliance Survey was undertaken by the Centre for Public Health Law and Policy, National Law University Tripura to measure the compliance of Sections 4, 5, 6a, 6b, 7, 8, and 9 of the Cigarettes and Other Tobacco Products Act (COTPA) in eight districts of Tripura. The purpose of the survey was to measure the effectiveness of existing measures and identify areas for improvement in tobacco control policies. The final report of the compliance survey was released by Shri J.K. Sinha IAS, the Chief Secretary, Government of Tripura on March 26, 2024. Pursuant to this event and subsequent letter written by Prof. Yogesh Pratap Singh, VC, NLU Tripura to Chief Election Officer, Tripura, all polling booth of Lok Sabha election was declared Tobacco free.



# Legal Awareness Camp



The National Law University, Tripura, in cooperation with the Gramin Bank of Tripura, hosted a Legal Awareness Camp in Narsingarh area on June 30, 2024. The focal point of the gathering revolved around the discourse on “Cyber-Crime in the Banking Sector”. 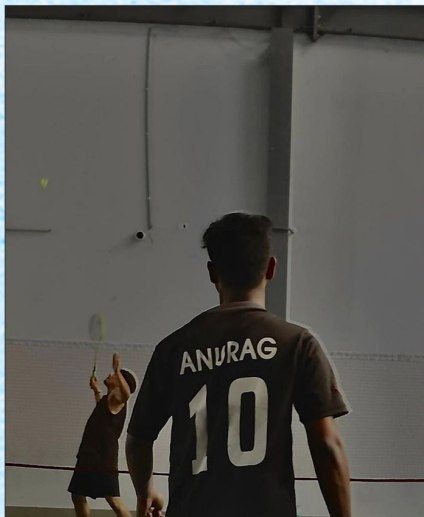
