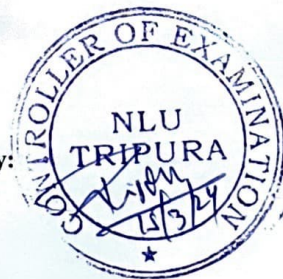





**Terms of Reference for Submitting Fees and Confirming the Seat for Admission to the Ph.D. Programme for AY 2023-2024:**

1. The Result of Ph.D. admission process for the academic year (AY) 2023-2024 is published including the overall general ranks and the reservation category-wise ranks secured by the applicants.
2. The reservation category is applicable only to the Scheduled Tribes (ST) and Scheduled Caste (SC) of the State of Tripura pursuant to the State law and as already mentioned in the Admission Brochure of NLU Tripura. SC and ST candidates of other States outside Tripura are treated under the general category.
3. **The provisionally selected applicants selected in the Main List under General, ST and SC categories are first invited to take admission to the Ph.D. programme on or before March 26, 2024 by the following steps:**
  - (a) All the provisionally selected applicants in the Main Lists who are presently working, especially with government departments/institutions or private/government-supported or aided colleges/universities in India or abroad, shall mandatorily submit a 'No Objection Certificate (NOC)' to take admission in the Ph.D. programme for AY 2023-2024 of the NLU Tripura and attend course-work classes (w.e.f. April 2024), pursuant to the publication of this result.
  - (b) No Objection Certificate can be accessed from the website of NLU Tripura under the section: [https://nlutripura.ac.in/PhD\\_Admissions\\_2023-24](https://nlutripura.ac.in/PhD_Admissions_2023-24)
  - (c) No Objection Certificate shall be submitted on or before March 26, 2024 along with the deposit of the fees and completion of the Online Enrollment Form, which can be accessed here: <https://forms.gle/HV7UncRbyJRYqyxE6>
  - (d) No applicant will be allowed to take admissions without a submission of NOC as stipulated above.
4. If the seats under the General category may fall vacant from the Main list, the provisionally selected candidates from the Waiting List in the General category will be invited to take admission in the Ph.D. programme. Such wait-listed applicants will be communicated via email on or before March 28, 2024.
5. The course-work classes will start in person on the NLU Tripura campus tentatively on April 15, 2024. After the fees are submitted, the detailed schedule will be communicated to the admitted applicants by the University's Examination Department.
6. The fees towards admission to the Ph.D. programme for AY 2023-2024 shall be submitted as per the Fee Schedule, available on the university website, under the section: [https://nlutripura.ac.in/PhD\\_Admissions\\_2023-24](https://nlutripura.ac.in/PhD_Admissions_2023-24)
